## Fund Overview

The Africa Sustainability Fund is a long-only, 50-stock equity portfolio diversified across African geographies, sectors and companies. The objective of the fund is to provide long-term investors with equity exposure to African companies within a sustainable investment framework at relatively low cost.

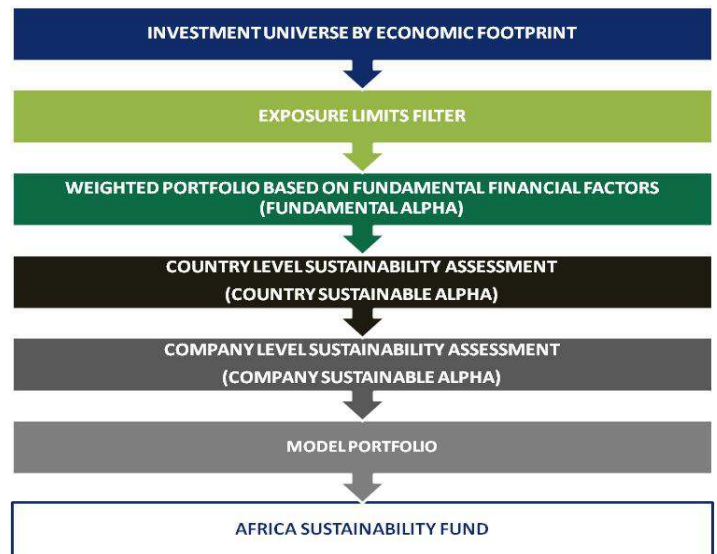
## Investment Process

The fund employs a rule based investment process which focuses on bottom-up stock selection. Stock selection is determined by a combination of market-value independent factors, including company-level fundamental financial factors (revenues, operating cash flows, cash dividends and net asset value) as well as Sustainable Capital's proprietary country and company sustainability ratings.

The fundamental financial factors implicitly introduce a strong value bias into the portfolio construction. The country and company sustainability assessments have the net effect of aggressively up-weighting the stocks and currencies in the most sustainably managed companies and countries (and vice versa). Targeted company engagement on material sustainability risks and opportunities is initiated with selected companies where a strong business and investment case is evident.

Sustainable Capital is an independent, owner-managed, responsible investment asset manager that specialises in the research and management of listed African equity securities, with total assets under management of USD 34.1m.

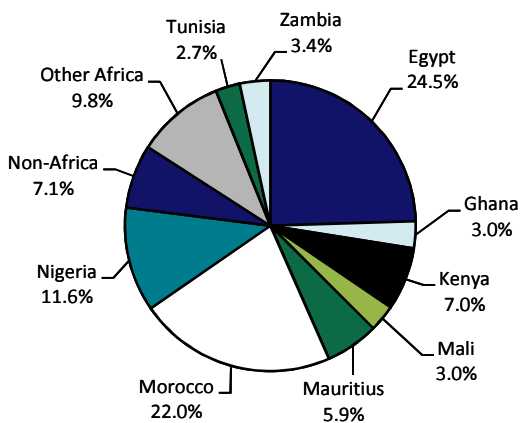

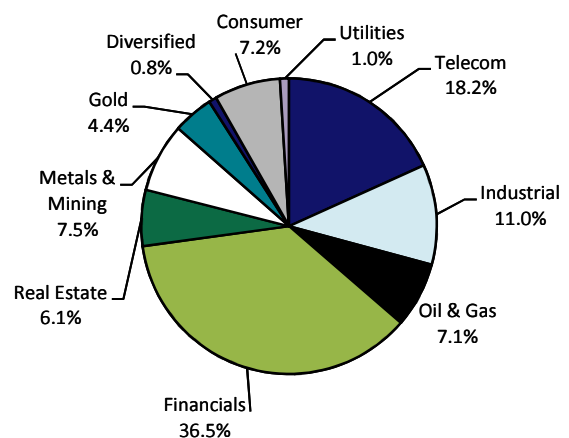

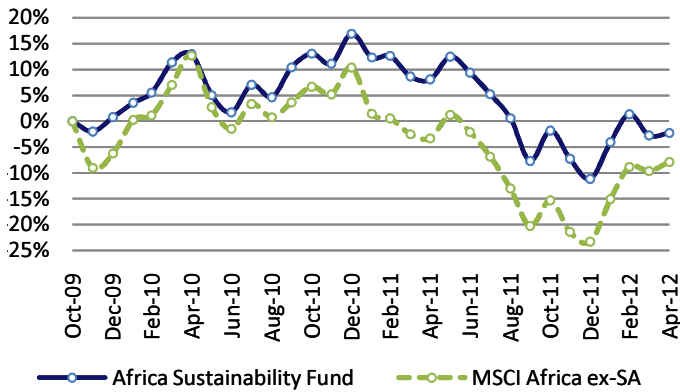

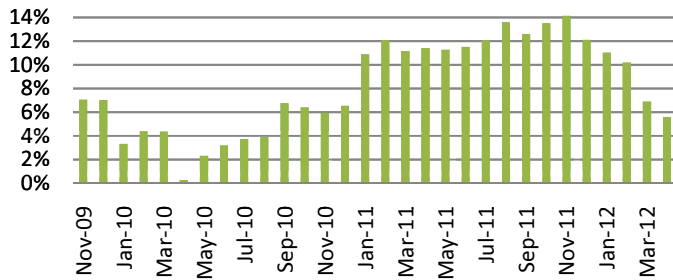

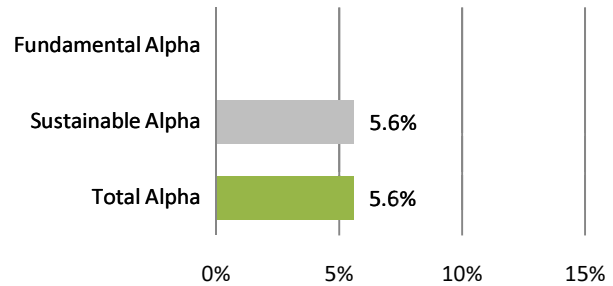
